During 2015, PMAC's bicycle-pedestrian ad hoc committee provided input to DCR and met with City of Boston officials from the traffic and public works departments to share park user input about SWC intersections with city streets.




PMAC also meets monthly with police from the city, state, MBTA and other jurisdictions to exchange updates about public safety along the park.

During the winter and early spring, PMAC launched a bicycle-pedestrian ad hoc committee to look at strategies for promoting safety and a culture of courtesy and civility on the SWC bicycle-pedestrian path. The committee conducted an online survey, talked with park users, looked closely at intersections, signs and traffic signals, and developed recommendations. The committee provided input to DCR and met with City of Boston officials from the traffic and public works departments.



#### **Public-private partnerships**

This was a productive year for public-private partnerships in the park, where community volunteers are responsible for initiatives from the **dog park** to the **eleven community gardens** and more.

One highlight this year is the formation of the publicprivate partnership for the **SWC Skatepark**, with construction to begin in 2016.

Another highlight is the addition of a herb garden raised bed in the park in JP from partnering organization, Herbstalk.



#### Looking ahead

Throughout the Casey-Arborway planning process, a PMAC representative has participated in the community planning process and provided a key communication link between park users and the planners. As this project is now in full swing, we look forward to the expanded parkland and neighborhood connections.

In 2016, PMAC will be working with the DCR on the Greenway Extension- a new quarter mile addition to the Southwest Corridor Parkland running between English High School and Forest Hills Station on the East side of the MBTA tracks. This piece of land has been fenced in for years but belongs to the MBTA and was left undeveloped after construction of the Orange Line and SWCP. Through an agreement with the BRA and Stonybrook Neighborhood Assoc (SNA) two new large Residential/Mixed Use developments on Washington St are contributing \$125,000 toward design and implementation of parkland here. The goal is to have this new Greenway Extension landscaped and with paths and lighting and integrated with the SWCP and Casey-Arborway Parkway.
